In response to RFAI letter dated 2/25/2012, allocation for the levin funds transfer corrected. Items 40262/40265 is the value of the in-kind contribution from Trilar Management Group for the use of office space . Prior to this transaction, the escrow balance was \$7,906.82. That amount was then reduced by the federal portion of the in-kind contribution ($\$408.50 \times 36\% = \147.06) leaving a new escrow balance of \$7,759.76.
