Please note that Daniel K. Gordon resigned as President of ProLogic, Inc. and Alternate Treasurer of the ProLogic, Inc. PAC effective May 14, 2010. Also on May 14, 2010, Paul Maguire was appointed as President of ProLogic, Inc. Under the original ProLogic, Inc. PAC Bylaws, the President of ProLogic, Inc. also held the position of Assitant Treasurer of the ProLogic, Inc. PAC. As a result, upon becoming President of ProLogic, Inc., Mr. McGuire automatically assumed the role of Assistant Treasurer of the PAC under the Bylaws. Effective May 21, 2010, however, the ProLogic, Inc. PAC's Bylaws were amended and restated to require the Chairman & Treasurer of the PAC to appoint the Assistant Treasurer (i.e., the position is no longer automatically held by the President of ProLogic, Inc.). After the Amended and Rested Bylaws became effective, on May 21, 2010 Gregory F. Thom was appointed as the Assistant Treasurer of the ProLogic, Inc. PAC, as reflected in this amendment.
