believe I may have inadvertently violated the 48 hour reporting rule, by not reporting those three large donations until 12/31/25. I looked back at the communications between myself and our bookkeeper, and found those three donations were in her reports to me via email on 10/29/25, which was after their receipt, but during the 48 hour reporting window. I must have missed them at that time, but caught them later when reconciling her excellent records with mine at year end. I will admit the error. Please advise as to whether I should at this time file amended 48 hour notices, or how to rectify the record of these three donations.

As to the second RFAI letter, also dated 6.25.25, pertaining to an explanation for the difference between the original filing and the third amendment, that difference is easily explained after a thorough review of both filings. I found several mistakes in the original filing, and fixed them with the amendment, none of which should cause a violation or fine. The mistakes were as follows:
