Dear Mr. Young:

I write in reply to your letter of November 17, 1998 concerning the October Quarterly Report of the Pete King for Congress Campaign of which I am treasurer.

I acknowledge and concur with your statement that one or more of the required 48-hour notices were not filed in the pre-primary filing period. The three in question are Ernst and Young PAC, Perry Weitz and American Medical Pac. This committee is well aware of the 48-hour notice requirement. You will see that we filed 48-hour notices both before and after the dates of the aforementioned contributions.

The 48-hour notices in question were inadvertently overlooked through human error and I have taken steps to see to it that this does not happen again. Two individuals will now review incoming contributions during those periods when 48-hour notices are required to be sent. This will help to assure that nothing falls through the cracks.

As to contributions received after the Primary which are designated for the Primary: this is an error committed by my software program which automatically checks the appropriate designation box on the form. In fact the contribution by American Maritime Officers PAC, dated 9/23/98, should have been properly designated as a general election contribution.

I enclose an amended report to present the contribution correctly.
