This letter is prompted by the Commission's preliminary review of the filing referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. An adequate response must be received at the Commission by the response date noted above. Additional information is needed for the following 5 item(s):

1. Your Statement of Organization (FEC Form 1) reports information about a Principal Campaign Committee; however, your filing fails to disclose information about the candidate. Commission Regulations require that the Statement of Organization disclose the name of the candidate, the office sought and party affiliation of the candidate. (11 CFR 102.2(a)(v)). Please amend your Statement of Organization to include the name of the candidate, the office sought, and party affiliation.

2. Your committee failed to designate a campaign depository on Line 9. Please be advised that each registered political committee must designate a campaign depository or depositories. The committee must maintain at least one checking account or transaction account at one of the depositories. Please amend your Statement of Organization (FEC Form 1) to disclose the committee's depository. $(11 \text{ CFR } \S 102.2(a)(1)(vi) \text{ and } 11 \text{ CFR } \S 103.2)$

3. Your Statement of Organization (FEC Form 1) does not include an email address for your committee. The Federal Election Commission sends all courtesy mailings exclusively by electronic mail. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
