I would like to take this opportunity to thank you for taking the time out to explain the FEC filing process to me last week. It was extremely helpful. As you may remember from our conversation the Committee for Farmworkers Programs-PAC would like to file FEC reports from 1992-1997.

As I explained to you, we recently took over the PAC (1996) and have not filed reports due to low activity of the PAC. The PAC is now administered out of Rochester, NY. When the PAC activities and administration moved to Rochester we carried over funds, but were unclear of the reporting requirements, if any to the FEC.


As per your instructions, please find attached our reports from 1992 to the present. You will find that between 1992-1996 the PAC was inactive, though we carried over a balance during that period.

In 1996 we began to receive small donations and made two disbursements to federal candidates. Entering 1997 we continued to receive donations, however as of December 31, 1997 we did not disburse any PAC funds.

I have submitted rather detailed reports for 1996 and 1997. Please review and inform me of any compliance changes that I may need to make. In addition you will find our Statement of Organization (FEC FORM 1), that reflects our change of address and treasurer. This should reinstate us into your system. Presently the PAC is "Administratively Terminated" by the FEC. We did not receive correspondence to that effect. If the Statement of Organization is not substantial for reinstatement, please forward me the procedures and/or documents to do so.
