During the August reporting period, an unknown individual created, forged and cashed six fictitious PAC checks totaling \$25673.12 and initiated 20 fraudulent ACH debits totaling \$11,070.10. In sum, the fraudulent activity totaled \$36,743.22. The Committee notified Truist Bank of the issue and the bank returned \$19,138.12 of the funds on 8/5/2022 for fraudulent transactions on 8/4/2022 and \$4,585.00 on 8/10/2022 for the fraudulent transaction on 8/9/2022 for a total of \$23,723.12. This report documents the disbursement and return of fraudulent funds during the August reporting period.
