On behalf of Benito Loyola, Jr., please find enclosed FEC Form 2, Statement of Candidacy. Mr. Loyola has not yet received contributions aggregating in excess of \$5,000 or made expenditures aggregating in excess of \$5,000, but expects to meet this threshold soon. 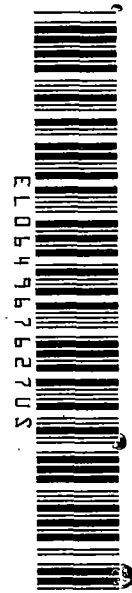
