
Attached please find a final report of receipts and disbursements ("Termination Report") for Citizens for Biden ("Committee"). Per our earlier conversation, the Committee's cash-on-hand has been adjusted upward to reflect approximately \$9,000 in contributions we believe were re-designated from Biden for President in March 2008 but inadvertently omitted in the applicable report covering that time period.

The Termination Report also reflects \$1,591.45 in interest income that the Committee received from TD Bank during the last quarter of 2008, but was not included in the Committee's January 31, 2009 Year-End Report.

Restitution payments the Committee is entitled to receive from Roger Blevins are now payable to Crime Victims Fund, US Treasury, and all remaining Committee funds have been disbursed to the Delaware Police Chiefs' Foundation and ZERO-The Project to End Prostrate Cancer – both are tax-exempt charitable organizations.

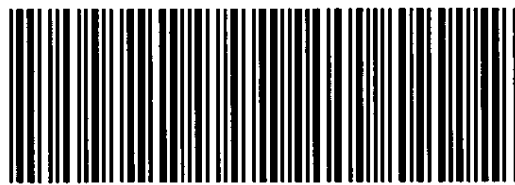
