This is to acknowledge receipt of your "remailed" letter of June 30, 2004, which I received in the mail today (enclosure 1).

You are correct that my treasurer, Carla Bartz, resigned on May 14, 2004 (enclosure 2).

I am in the process of closing out my campaign books as I am no longer running for the Senate. The problem is that when I shut down my office in Mid-May of 2004 the post office did not forward my mail to my home address at 9012 Rocky Lake Court, Sarasota, Florida 34238. Therefore, the treasurer's letter and other mail were held in the post office for several weeks. This is why your letter did not reach me until today.

I finally received the treasurer's resignation letter on June 25th and your letter on July 7, 2004 after tracking down my mail in the "dead letter file" of the post office in Atlanta.
