This letter is prompted by the Commission's preliminary review of the report(s) referenced above. 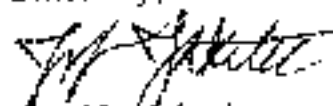
-Line 5(d) of your Statement of Organization indicates that you are a state party committee for the Pennsylvania Democratic Party; however, there is already a Pennsylvania Democratic Party committee registered with the Commission. It appears that your committee is a subordinate committee of the Pennsylvania Democratic Party. Please amend your Statement of Organization to properly reflect your "Type of Committee" on Line 5(d).

-Please clarify your relationship, if any, with Pennsylvania Democratic Party, which appears to be an affiliated committee. For further guidance on the question of affiliation, please refer to 11 CFR §100.5(g) and §110.3. If your committee is affiliated with the Pennsylvania Democratic Party, you should amend your Statement of Organization to reflect this relationship as "affiliated" on Line 6 and delete the indicated "Type of Connected Organization."

Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. Requests for extensions of time in which to respond will not be considered. Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
