

Thank you for taking the time to speak with me recently regarding QPAC's June 8 contribution. As I mentioned on the phone, QPAC inadvertently issued the June 8 \$1,000 check prior to attaining multi-candidate status. In an effort to clarify the public record, we would like to request a refund of that contribution.




