The Next Century Fund received a letter from the FEC dated March 16, 2007 which indicates that this contribution to the Mark Kennedy Victory Committee (FEC C00424259) together with previous contributions to the Mark Kennedy 06 (FEC C00409946) may have exceeded the \$5,000 per election limit for Federal candidates. Although both the Mark Kennedy Victory Committee and the Mark Kennedy 06 committee are linked to the same candidate (i.e., Mark Kennedy), they are separate and distinct FEC-registered committees and thus contributions to one do not necessarily preclude contributions to the other. The Next Century Fund's contributions to the Mark Kennedy 06 committee did not exceed the legal limits. We contributed \$5,000 to this committee for the primary election (April 2006 Quarterly) and \$5,000 for the general election (October 2006 Quarterly). However, after making this contribution to the Mark Kennedy Victory Committee, it was learned that it may have exceeded the legal contribution because of a previous \$25,000 contribution to the NRSC Special Team 2006 Committee since one of the joint beneficiaries of this NRSC committee is the state party of Minnesota. Therefore, a refund was requested by letters dated November 2, 2006 and April 4, 2007.
