Dear Mr. Forkiewicz,

The Congressional Leadership Fund ("CLF") has received your letter dated April 3, 2013, regarding CLF's AMENDED 30 DAY POST-GENERAL REPORT (10/18/2012 - 11/26/2012), RECEIVED 12/19/2012. Your letter raises three questions, responses to which follow:

1. Your letter seeks additional information regarding a total increase of \$59,264.18 in contributions disclosed on CLF's Amended July Quarterly Report (4/1/12 - 6/31/12), received 12/19/12; CLF's Amended October Quarterly Report (7/1/12 - 9/30/12), received 12/19/12; and CLF's Amended 30 Day Post-General Report (10/18/12 - 11/26/12), received 12/19/12. As indicated in those amended reports, CLF disclosed \$55,264.18 in additional in-kind contributions for fundraising services and - as required when a political committee receives an in-kind contribution - CLF disclosed a corresponding \$55,264.18 in fundraising expenditures. These in-kind contributions were not included in CLF's original reports due to an administrative oversight that has now been corrected.

In addition, a vendor who had been recently retained by CLF belatedly notified CLF of a \$4,000 contribution received in June. That contribution was disclosed on CLF's Amended July Quarterly Report (4/1/12 - 6/31/12), received 7/27/12. CLF has since restructured its relationship with the vendor.

Please note that CLF filed the amended reports as soon as possible after learning of these omissions.

2. Your letter also identifies a discrepancy between the Column B Calendar Year-to-Date entries on the Summary Page and Detailed Summary Page of CLF's Amended 30 Day Post-General Report (10/18/2012 - 11/26/2012), received 12/19/12, and CLF's previous report, the Amended 12 Day Pre-General Report (10/1/12 - 10/17/12), received 10/26/12. The discrepancy was caused by the increase in total contributions and expenditures that were included in the amended reports described immediately above. CLF has filed an Amended 12 Day Pre-General Report (10/1/12 - 10/17/12) to correct the discrepancy.

3. Finally, your letter indicates that CLF may have been one day late when it filed a 24 hour report of an expenditure made on 11/2/12. The expenditure disclosed on that report was not processed through CLF's normal procedures which are designed to expeditiously account for, record, and file 24 hour reports. CLF filed the 24 hour report as soon as it was able to properly account for the expenditure, which was on 11/4/12.

I trust this adequately responds to your letter. Please let me know if I can provide any additional information.
