Thank you for your correspondence regarding errors in federal election campaign finance disclosure reports filed by Dairy Farmers of America, Inc. Political Action Committee, also known as DFA-PAC. DFA-PAC has reviewed your correspondence and agrees that previously filed reports contain errors in information required to be reported on Schedule A of DFA-PAC?s monthly disclosure report. The information on these reports contains an accurate listing of the amount of funds DFA-PAC received, but due to an inadvertent administrative error, these reports used an internal Dairy Farmers of America, Inc. farm reference description that only partially identifies the dairy farm cooperative member making the contribution. DFA-PAC receives that the information required for an FEC filing differs from the internal descriptors used by Dairy Farmers of America, Inc. and will both provide amended historical reports and correct the error going forward.

DFA-PAC is committed to timely providing information that facilitates a full public disclosure of federal election campaign finances. DFA-PAC takes its disclosure obligations seriously and has at all times intended to comply with all applicable statutes, regulations and rules. Additionally, DFA-PAC is reviewing its internal procedures regarding FEC correspondence and will take immediate steps to ensure that FEC communications are appropriately handled and addressed.

DFA-PAC is taking the following steps to remediate the issues identified by the Reports Analysis Division:

1.Seeking counsel and training on correct reporting ? DFA-PAC has sought advice from outside counsel experienced in FEC matters to assist DFA-PAC in ensuring future reports contain the necessary information to inform the public of the precise source of every contribution to DFA-PAC. Based on DFA-PAC?s investigation, it appears that administrative staff

utilized an internal nomenclature for reporting contributions, rather than the full name of certain LLCs or partnerships, along with the appropriate memo entry detailing the appropriate itemization to LLC or partnership members.

2.Analyzing previously filed reports ? It appears to DFA-PAC that all of the errors identified by the Reports Analysis Division relate to LLC or partnership contributions from members of DFA-PAC?s restricted class. DFA-PAC is evaluating its reports to see if any other contributions contain similar errors, regardless of whether the Reports Analysis Division has identified an error to date. This includes both disclosure reports identified by the Reports Analysis Division as potentially problematic, as well as other disclosure reports.

3.Amending reports as necessary ? DFA-PAC commits to amend previous filings containing errors on or before October 5, 2018.

4.Return of excess funds, if any - At this time, DFA-PAC is not aware of any contribution amounts that need to be refunded. However, should DFA-PAC become aware of any impermissible or excess contribution, DFA-PAC will promptly refund

such contribution.
