
Dear FEC,



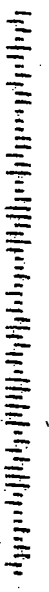
