Dear Mr. Goode:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. An adequate response must be received at the Commission by the response date noted above. An itemization of the information needed follows:

"Your committee has checked the box for Line 5(a) which is used by a candidate's principal campaign committee. However, on Line 6 you indicate that you are affiliated with the "New Jersey Democratic State Committee". Please amend your Statement of Organization to clarify this apparent discrepancy.

If your committee has <u>not</u> been authorized by a candidate to act on their behalf as evidenced on their Statement of Candidacy, please do <u>not</u> check the box for Line 5(a). If your committee is responsible for the day-to-day operation of a political party, then please complete the information for Line 5(d). Please refer to 2 U.S.C. §433 and 11 CFR §102.2 and the instructions for the Statement of Organization (FEC FORM 1) for further information.

-Your filings disclose that your committee may have satisfied the criteria set forth at 11 CFR §100.5(e)(3) for becoming a multicandidate committee; however, the Commission has no record of a FORM 1M (Notification of Multicandidate Status) filed by your committee. Please he advised that once a political committee meets the certification requirements or becomes

affiliated with an existing multicandidate committee, whether or not that political committee has certified its status as a multicandidate committee, it automatically attains multicandidate status and must file a FORM 1M (Notification of Multicandidate Status) within ten (10) calendar days.

For further guidance on the multicandidate certification requirements, please see 11 CFR §§102.2(a)(3), 110.2(a)(1) and (2). Please submit a FORM IM to disclose the required information for the public record. A copy of FEC FORM IM can be downloaded from the FEC website at http://www.fec.gov, or requested through the FEC Fax line at (202) 501-3413.

Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. Requests for extensions of time in which to respond will not be considered. Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
