This Levin transfer was made to cover the nonfederal portion of allocable administrative expenditures, not FEA. However, there is no category in the FEC File system for designating a transfer of Levin funds to cover the nonfederal-eligible portion of an expenditure rather than one of the four types of FEA. We therefore reported the amount of this transfer under 'generic campaign activity,' but please accept this memo as notification that this transfer covers the nonfederal portion of the relevant administrative expenditures. Specifically, the two Levin transfers reported here amount to \$1,946.47. This covers the 79% nonfederal-eligible reimbursement for the (a) 4/3/14 B. Blackmer expenditure (total 750.00, with 595.50 reimbursable with nonfederal funds); (b) 5/2/14 B. Blackmer expenditure (total 794.58, with 627.72 reimbursable from nonfederal funds); and \$726.25 towards the (c) 5/8/14 EFTPS expenditure (total 1,981.98, with 1,565.76 reimbursable from nonfederal funds).
