I am writing to you to ask for your assistance in clearing up what appears to have been some confusion as to previously filed Statements of Candidacy. Enclosed please find the Statement of Candidacy which I filed on May 21, 1997 with regard to a possible congressional run in the 4th District of Iowa. [Exhibit 1] I was advised by Greg Scott of your office that it was not necessary for me to file any reports or send in organizational information if I had not decided to become a candidate at that time. After receiving this information, I informed the Committee via a letter sent on July 29, 1997, a copy of which is enclosed.
