Dear Mr. Francis:

This letter is to clarify two items on the Utah Republican Party's FEC report covering 4/1/98 to 6/30/98.

The first matter concerns a contribution of \$10,000.00 from John Price which can be found in the itemized receipts on Schedule A. While the money was deposited into our federal account, which would exceed the individual limit for Mr. Price, we transferred \$5,000.00 of it that same day, 5/5/98 into our state account, and transferred the rest of it, \$5,000.00 into our state account the next day, 5/6/98. The contribution, consequently, was not used as federal money. Hopefully, this will remedy any potential problem with contribution limits.

The second matter is concerning small contributions from delegates at our state convention. All contributions are under \$200 and are listed under Offsets to Operating Expenditures on Schedule A.


