Dear Mr. Mazzeola,

In reply to your letter dated October 13, 2014, I have reviewed the details of the unitemized contributions made during this period. I am quite confident that there were, in fact, \$608,292.13 in unitemized contributions, in other words small contributions which did not aggregate to more than \$200 yet in the 6 year cycle (2012 – 2018).

Our Data Base is set to itemize at the \$200 aggregate and we go through and combine any duplicate records that have accumulated before each report.

For the second quarter of 2014, we received a total of 16,072 contributions (on average about \$44 each). Only 276 of those contributions were from people who had given a total greater than \$200 since the election in 2012. Here is a breakdown by amount:

58 - \$1 or less

703 - \$2 - \$5

1,712 - \$5-10

2,437 - \$10-20

8,890 - \$20 - \$50

1,766 - \$50- \$100

348- \$100 - \$200

15,904 contributions totaling \$615,466
