This response pertains to the Reports Analysis Division's ("RAD") Request for Additional Information ("RFAI") dated September 4, 2025, regarding Scalise for Congress's ("SFC") July Quarterly report filed on July 15, 2025.

1. Please see below for details regarding the contributions that exceed the limits set forth in the Act.

Bryden, Elizabeth – The excess contribution resulted from a software calculation issue in a JFC. This was corrected on a JFC distribution processed on 9/29/2025 and will be reflected on the October 15, 2025 Quarterly report.

Levy, Edward C. Jr. – The JFC, Team Scalise, over distributed for Primary 2026. An 9/26/2025 distribution corrected the over-distribution, which will be reflected on the October 15, 2025 Quarterly report.

Nau, John L. III – The excess contribution resulted from a software calculation issue in a JFC. This was corrected on a JFC distribution processed on 9/29/2025 and will be reflected on the October 15, 2025 Quarterly report.

Reese, Stuart – The excess contribution resulted from a software calculation issue in a JFC. This was corrected on a JFC distribution processed on 9/29/2025 and will be reflected on the October 15, 2025 Quarterly report.

Louisiana Health Service & Indemnity Company DBA Blue Cross and Guidewell Mutual Holding Corporation Political Action Committee (Guidewell PAC) – Due to an administrative error, a contribution from a joint fundraising distribution dated 6/23/25 incorrectly attributed \$5,000 from Guidewell PAC to the primary election. The adjustment will be reflected on the October 15, 2025 Quarterly report to correctly attribute the \$5,000 contribution from Guidewell PAC to the General 2026 election.

Dow Inc. PAC (DOWPAC) and Corteva Inc. Employees PAC (Corteva Agriscience PAC) – Due to an administrative error, a contribution from a joint fundraising distribution dated 6/23/25 incorrectly attributed \$5,000 from DOWPAC to the primary election. The adjustment will be reflected on the October 15, 2025 Quarterly report to correctly attribute the \$5,000 contribution from DOWPAC to the General 2026 election.

2. Regarding the contribution from United Health PAC, a non multi-candidate committee, due to an administrative error, a contribution from a joint fundraising distribution dated 6/23/25 incorrectly attributed \$1,500 from United Health PAC to the primary election. The adjustment will be reflected on the October 15, 2025 Quarterly report to correctly attribute the \$1,500 contribution from United Health PAC to the General 2026 election.

3. Regarding Column B discrepancies, the July Quarterly report was corrected and amended with FEC-1917682.
