
Please find enclosed the year-end report covering SheetzPAC's 2018 activity, as well as quarterly reports for July and October 2018 and Post General Election report.

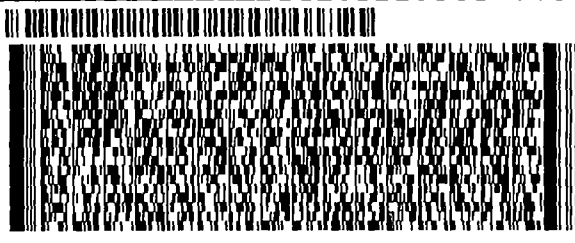

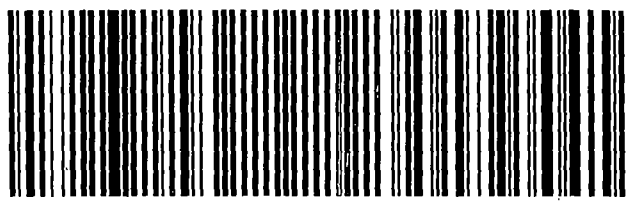
