Dear Ms. Hanna,

I am writing as counsel to Win Justice (Committee) in response to your August 12, 2021 request for additional information (RFAI) related to the Amended 12 Day Pre-General Report filed by the Committee on January 4, 2021 (Amended Pre-General Report).

The RFAI states that the amounts and dates of public dissemination disclosed on 48-hour reports regarding certain independent expenditures made in support of Joseph R. Biden do not appear to correlate with the entries on Schedule E, supporting Line 24 for the reporting period on the Amended Pre-General Report.

The Committee has reviewed the relevant 48-hour reports and determined that while the amounts disclosed on those reports are the same as those disclosed on Schedule E of the Amended Pre-General Report, in two instances the dates of public dissemination disclosed on the 48-hour report disagreed with those on the Amended Pre-General Report. Specifically, on the amended 48-hour report filed on November 4, 2020 (FEC-1471508), the Committee disclosed two expenditures, in the amounts of \$54,050.00 and \$65,323.00, with TOSKR, Inc dba GetThru as the payee and October 9, 2020 as the date of public dissemination. On the Amended Pre-General Report, these expenditures were listed with October 10, 2020 as the date of public dissemination.

The Committee has determined that the October 9, 2020 date disclosed on FEC-1471508 was the correct date of these expenditures. Accordingly, the Committee filed an additional amendment to the Amended Pre-General Report on September 15, 2021 (FEC-1537759).
