

1. Welcome/Call to Order

Because this is an issue that many feel that there is nothing they can do anything about, it will also focus on concrete actions we can take to protect and support our neighbors.

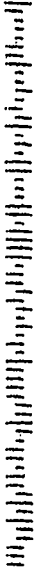
