Enclosed is a photo copy of the debts that the former Chairman Betsy Lake and the former Treasurer Edward Chen filed with the Federal Election Commission on December 1, 1992. As we understand it, the F.E.C. regulations state in article 11 CFR ss102.3(a), no organization can terminate unless arrangements have been made in regards to their debts.


As the F.E.C. Form 3X shows, the above named officials left the Republican Party of Harris County with debts totaling \$25,526.71; the actual amount they were in debt is considerably higher. This is shown in the photo copying of several checks. These other debts reflect payments not made on office equipment, taxes, and other miscellaneous outstanding debts.


The current leadership of the Republican Party of Harris County, under the direction of its Advisory Committee which is chaired by Dr. Steven Hotze, has either paid off all of these debts in full or negotiated a settlement. Letters have been enclosed with the corresponding checks with regards to those debts in which a negotiated settlement was reached and agreed to by both parties.

The current leadership has decided, in light of the fact that we have made good on the outstanding debts, that we will continue to operate under the same Federal Identification Number, C002351 and name; The Republican Party of Harris County.
