## **Dear Federal Elections Commission:**

As directed by your office, this letter is in lieu of a formal termination report for Campaign Committee Azcona for Congress – FEC ID Coo553032 – as this committee has voluntarily filed and has not reached \$5,000 raised or spent.

At this time, the Campaign Committee and Candidate have not reached Florida's State requirements to appear on the ballot for US Representative District 7, 1% of registered voters. As the candidate will be unable to appear on the ballot, the campaign and committee are now dissolved with no intentions of acting as a committee for any other candidate, party or political action committee

Please note that due to the Candidate's platform the Campaign Committee – Azcona for Congress had not been accepting donations or making expenditures for the campaign – no committee members or campaign staff received compensation from Candidate or the Committee, all personnel were volunteers and aware of such status. The campaign was personally funded by the Candidate, Alan Azcona.

As of April 1, 2014 the Committee and Candidate suspended all activity for a period of evaluation. As of April 22, 2014 all expenditures and independent contributions reflect those reported in the previously issued quarterly report.
