Candidate Georgene Louis completed FEC Form 2 and mailed a paper copy via FedEx to the Federal Election Commission (FEC) on January 15, 2021. When calling to confirm delivery the candidate's campaign was told the building was closed and the original paper FEC Form 2 had not been processed. After checking the tracking number with FedEx the campaign determined the paper FEC Form 2 had been delivered to the Federal Election Commission at the address 1050 First Street, NE Washington, DC 20002. In the meantime, the candidate filed FEC Form 1 electronically within the 10 day period required to establish the principal campaign committee. After receiving our campaign committee's FEC identification number we were then advised by the FEC that since FEC Form 1 had been filed electronically the candidate would be required to file FEC Form 2 electronically. Today we submit FEC Form 2 electronically although a paper copy was mailed and delivered - although not processed -previously to the FEC.
