In response to Karen Trainer's letter dated 2/8/05, this filing amends the Committee's amended October monthly report (9/1/04-9/30/04) to correct 3 clerical errors, detailed below. Except for correcting the following 3 errors, the report filed herewith is identical to the previous report: Schedule A: The reported receipt of \$2300.00 on 8/17/04 from 'Local 13 Labor Day Breakfast' was mistakenly entered in Schedule A as an itemized receipt. This was not a contribution from one person or entity. Rather, this was an event sponsored by the connected organization (LWU), at which LWU members purchased t-shirts as promotional items to raise funds for the committee. The \$2300.00 reported is the total amount received at this event from members for purchase of t-shirts, for less than \$50.00 each. This amended report decreases by \$2300.00 the amount of itemized contributions reported at Detailed Summary Page, line 11(a)(i), and increases by \$2300.00 the amount of unitemized contributions at line 11(a)(ii). Schedule B: The reported contribution of \$1000.00 on 9/22/04 to Michaud for Congress mistakenly reported this contribution as having been disbursed for the 2004 primary election, when it was, in fact, for the 2004 general election. Schedule E: The reported independent expenditure of \$3,488.94 on 9/8/04 in support of Kerry was in fact for the 04 general, not primary as reported.
