This amendment provides clarifying disbursement information requested by the Commission concerning the Anadarko PAC's contributions to a joint fundraising committee. Further research of our records indicates that the individual checks were not simply designated to the candidates through the NAW 2004 Committee but rather written directly to each participant's committee. Though the NAW 2004 Committee has already reported the receipt of each contribution directly from the Anadarko PAC (which mirrors this PAC's original disclosure). In subsequent discussions with both the Reports Analysis and Information Divisions we have now been advised to change our itemization of these 5 contributions disclosed on Schedule B supporting Line 23 - making no notation of the joint fundraising committee. Accordingly, we have reported the five contributions (to the Bond, Grassley, Specter, Bennett and Brownback committees on pages 51-53) in question. The Commission should make the appropriate data changes. There are no other changes to this report.
