This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

Co. and Lew Webb's Irvine Nissan; however, it appears that the receipt of these contributions has not been reported by your committee. Please provide the original date of receipt for these contributions. In addition, you must amend the reports covering the periods during which the contributions were received to disclose the receipts on Schedule A supporting the appropriate line of the Detailed Summary Page. 11 CFR §103.3(b)(1)

-Please clarify the nature of the disbursements disclosed as "PAC Refund" on Schedule B for Line 29.

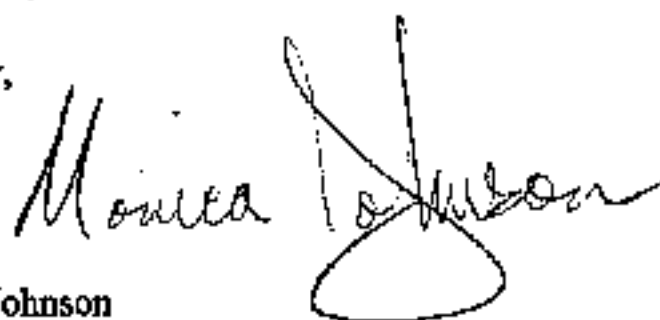

Please note that if no designation is included in your report, the contribution will be attributed to the next upcoming election for the recipient candidate. -Your report(s) was not signed by the treasurer or designated agent listed on your Statement of Organization. Please amend your report(s) by providing the signature of an individual that is authorized to sign the report(s). 2 U.S.C. §434(a)(1) and 11 CFR §104.14(a) and (d) If a new treasurer has been appointed, please file an amended Statement of Organization (FORM 1) or a letter to reflect this change.

-Your report includes computer produced formats of Schedules A and B. Computer produced formats may only be used upon prior approval of the Commission.
