This Amendment is filed in response to the Commission's preliminary review of the Rangel for Congress ("Committee") Year End Quarterly Report ("Report"). The Commission's review (1) identified that the Committee omitted addresses in Schedule B supporting line 17 of the report and (2) requested clarification of an itemized disbursement described as "Administrative Error". The missing addresses have been included in this report. Regarding the "Administrative Error" disbursement, the Committee paid 12,500 inadvertently to Ms. Bull-Henry, who made a personal loan to Mr. Rangel for non-campaign purposes. When it realized the mistake that it paid a personal loan and not a campaign loan, the Congressman re-reimbursed the campaign 12,500. The reimbursement will appear in the April 2016 Quarterly Report. Please also note that the disbursement to Kathy Bull-Henry has been moved to Schedule B, supporting line 21 in this amendment.
