This letter is in response to the Request for Additional Information (RFAI) dated September 11, 2016 with respect to the July Quarterly Report filed electronically on 7/15/2016 on behalf of the aforementioned committee and covering the period from 04/01/2016 through 06/30/2016.

1.In Schedule A of the July Quarterly Report, itemized contributions received from four donors were properly and fully reported in the field "Amount of Each Receipt this Period.? However, and as a result of an error in the manner in which data was exported from the FEC compliance software utilized by the Committee, the "Aggregate Year-to-Date? field was improperly left blank, leading to "\$0.00? being reported as aggregate contributions for these four donors. Since the Committee was formed and registered with the FEC on June 2, 2016, and since the July Quarterly Report contains a record of all contributions and disbursements of the Committee through June 30, 2016, there were no additional donations received in any prior period that would have caused the Committee to report any aggregate contributions in excess of the information already disclosed to the public in the "Amount of Each Receipt this Period.? An amended July Quarterly Report was filed electronically on October 15, 2016 duplicating and correcting the reported aggregate contributions in the proper field. The Committee and Committee Treasurer have taken steps to address the way data is exported to prepare its quarterly reports to the FEC and to ensure that the information regarding aggregate year-to-date contributions of each contributor are properly tallied and included in the reports of the Committee moving forward.

2.In Schedule B and Schedule E of the July Quarterly Report, certain disbursements and certain independent expenditures were improperly designated as expenditures in connection with a primary election, a national convention, or not designated in connection with any particular election in 2016. Upon further legal review and consultation with certain staff members in the Reports Analysis Division of the FEC to understand the way in which all disbursements and independent expenditures need to be identified as having been made in connection with a particular "election? as the term is defined in statute and in the regulations and of the Commission, the Committee amended its July Quarterly Report on October 15, 2016 to properly report all disbursements and independent expenditures in Schedule B and Schedule E to clarify that all such expenditures relate to and were intended and designed to influence the November 2016 General Election. The Committee and Committee Treasurer have taken steps to address the way disbursement and independent expenditure information is entered and maintained in order to ensure that all expenditures that relate to and are intended and designed to influence the November 2016 General Election are properly identified as such in the reports of the Committee moving forward.
