Please understand that nothing herein constitutes a waiver, or any intent to waive, knowing or unknowing, voluntary or involuntary, of any manner or kind, explicit, implied, constructive, real or imagined, theoretical, or hypothetical, by any statutory, legal, or artificially contrived definition, of any of the inalienable and Constitutionally-guaranteed Rights granted not only myself, but indeed each and every United States citizen, by and through binding and irrevocable force of Law, as plainly and clearly, in letter and spirit, enumerated by The Declaration of Independence and The Constitution of the United States, including, but not limited to, The Bill of Rights, especially the Free Speech, Equal Protection, Cruel and Unusual Punishment, and Due Process Clauses, as set forth in Amendments I, IV, VIII, and XIV. Thank-you.

No one, except for me, is authorized to act, in any manner, as agent, guardian, trustee, conservator, controller, comptroller, parent, family, lawyer, paralegal, adviser, social director, religious minister, physical or mental therapist, in any function or capacity, official, unofficial, personal, express or implied, directly or indirectly, on behalf of or for either me, TNC, or any related entities, any of his or their Assets, financial or otherwise, without my explicit, knowing and voluntary consent.

Pursuant to United States Code, Title 2, Subchapter 1, Section 433, as follows is the Statement of Organization of the national committee of The Trinity Party, the Trinity National Committee (TNC):

TNC has, since its inception, now has, and always shall have, as its primary purpose, the preservation, defense and strengthening, through appropriate means, of The Declaration of Independence, The United States Constitution, The Bill of Rights, and the spirit of the Founding

Fathers of this great Nation.

In the Campaign and General Election of 2008, The Trinity Party, TNC, and, Olivier Lodewijk Ferdinand Asser shall fulfill their solemn Oaths to the American People through various means, including, but not limited to, support of the Election of Olivier Lodewijk Ferdinand Asser as forty-fourth President of the United States of America.

Through these Articles of Incorporation, Olivier Lodewijk Ferdinand Asser is hereby Declared the uncontested and sole Trinity Party Nominee for the Office of President of the United States of America in the November 4, 2008 General Election.

As TNC Chairman, the Undersigned hereby Proposes and Declares:

Douglas Kennedy

to be the Trinity Party Nominee for Vice President of the United States of America.

Further, Olivier Lodewijk Ferdinand Asser shall, under binding signature, shortly nominate Proposed Cabinet Appointees to all existing and proposed Federal Agency positions, including, in order to adequately prepare for appropriate Administration of the Federal Government, bestowing Cabinet Rank on proposed existing and new Federal officials in The Administration. The proposed Cabinet shall be comprised of distinguished and qualified members of both the Democrat, Republican, other Parties, and other men and women so qualified, men and women who have served, and whom continue to serve the Nation selflessly, honorably, and, above all, to the highest standards of moral and ethical character and integrity.
