Dear Mr. Harris:

Thank you for the generous contribution Teligent PAC made to Mikulski for Senate. I know that Senator Mikulski is deeply grateful for your support.

In fact, you have been too generous and enthusiastic. According to the Federal Election Commission regulations your political action committee has not qualified as a multi-candidate committee. This limits your contributions to \$1000 per election cycle. Although you did not exceed the contribution limit for the aggregate cycle, the contribution your committee made was not designated \$1000 for the primary election cycle, and \$1000 for the general election. This requires that we return \$1000 of your contribution. Enclosed with this letter is a check from Mikulski for Senate reimbursing your political action committee for this contribution.
