The committee notes that 2 members of the Viacom Board of Directors are implicated in FEC MUR #7304, discussed in this billboard, as potentially making illegal 5- and 6- figure excessive, strawman contributions laundered through state Democratic parties to the Democratic National Committee and ultimately to the Clinton campaign, pursuant to public statements of DNC Chairperson Donna Brazile.
