Dear Mr. Jones:

This is my response to your letter dated March 11, 2024.

During the fall of 2023, I knew I wanted to run for the US House in 2024, but I hadn't completely decided whether to run in District 6, which is where I had run in 2014, 2016, 2018, 2020 and 2022, or in District 3. I finally decided to run in District 3 and filed my candidacy papers with the Kentucky Secretary of State's office on December 5, 2023. I didn't know whether I would need a new committee number and a new candidate number. I looked at Form 2, the Statement of Candidacy form, noticed that it asked which district I was running in, concluded that I must need a new committee number, and mailed it to the FEC on December 12, 2023. Looking today at my copy of the form, I noticed that I put "C00793307" in the box that was labeled, "FEC Candidate Identification Number," which means that I was already somewhat confused.

At the time I didn't think I needed a new candidate number because I'm the same person I was in 2022, 2020, 2018, 2016, and 2014. I thought if I got a new campaign committee number I would have done everything I had to do for 2024. Between December 15 and December 29, 2023, I kept checking the FEC website to see if my Form 2 had been processed yet, but it hadn't been.

On December 29, 2023, I called your office number and left a message asking, "Will I

get a new committee number? Will I get a new candidate number too? If so, when?" But you never called me back.

On January 4, 2024, I called the FEC General Contact number and talked with an extremely helpful person named Maryann, who told me that the FEC had received my Form 2 on December 14, 2023 but that "We don't have your Form 1." She said I should fill out and file Form 1 and mail it to the FEC using the address "First Street" instead of 1st Street. I did that and mailed it on January 4, 2024. After a week or two, I got a new campaign committee number and a new candidate ID number, and the problem seems to have been resolved.

Today, I went to the FEC gov website, https://www.fec.gov/data/candidate/H4KY03251/ and found that I have the candidate number H4KY03251 and the campaign committee number **C00865287.** I found my Form 2 here:

However, when I looked for my complete Form 1 on the FEC website, which I had mailed to the FEC on January 4, 2024, I couldn't find it. I am therefore enclosing another copy of my completed Form 1.
