Dear Mr. Decker:

I am in receipt of your letter, dated August 18, 2004, concerning your request for an amended "Statement of Organization" clarifying whether we have any affiliated committees or connected organizations. We do not. I have attached an amended statement herein, to address your questions and concerns.

Please note, however, that we are a little bit irritated that we are being asked to mail in this form again, with the addition of the word "NONE" on line 6, because FEC FORM 1 does not state anywhere on its face that we must do so. Hence, we thought that leaving that portion of the form blank (as we did in our initial filing) was a clear indication that there were indeed no affiliated or connected committees for our PAC. We suggest that in the future, the FEC amend FEC FORM 1 to specify on the document that "NONE" be written on line 6 to indicate the absence of affiliated organizations. This might prevent the wasting of postage and federal resources in the future, as well as the time necessary to correct such bureaucratic and immaterial errors on the part of small PAC's like ours. This time would be better spent saving our democracy.
