
Please find enclosed my termination report for the political action committee Draft Don Jr., C00725713. An explanation of my reasons for termination follows.

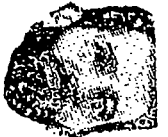

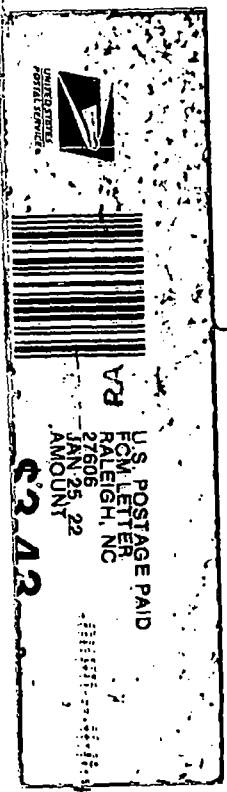

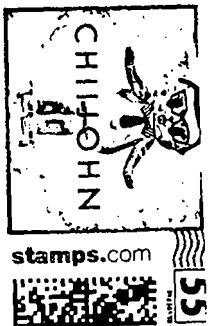
