Effective October 1, 1995, Community Mutual Insurance Company (CMIC) merged into the Associated Insurance Companies, Inc. of Indianapolis, Indiana (Associated). As a result of this merger, essentially all of the operations that were previously carried on by CMIC, including the Community Mutual Good Government Program, have been transferred to a new subsidiary of Associated, called Community Insurance Company (CIC).
