In January 2026, all employees worked less than 25% of their time on FEA activities. Therefore, all employee's payroll, payroll taxes & related benefits are allocable disbursements.

Our procedures for requesting the identification of all individuals who contribute in excess of \$200 in a calendar year are 1. Our original solicitation includes a clear and conspicuous request for the contributor information and informs them of the federal requirements for reporting such information, 2. For each contributor who did not provide this information, we mailed a letter requesting the missing information. We informed the contributor of the federal requirements for disclosing this information and we included a pre-addressed return envelope for their response. We made a concerted effort to send these follow-up letters as soon as possible after receipt of each contribution. When we receive responses from our donors regarding their employees and occupations, we include them in our next report as Best Efforts memos.
