

This letter also conveys my acknowledgement that all outstanding debt due me from the campaign is hereby forgiven.

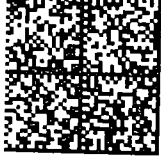

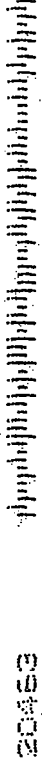
