This letter is prompted by the Commission's preliminary review of the report referenced above. 1. The totals listed on Lines 6(c), 7, 11a(i), 11(a)(ii), 11(a)(iii), 11(d), 15, 16, 19, 20, 21(b), 21(c), 23, 31, and 32, Column B of the Summary and Detailed Summary Pages appear to be incorrect. Column B figures for the Summary and Detailed Summary Pages should equal the sum of the Column B figures on your previous report and the Column A figures on this report. Please file an amendment to your report to correct the Column B discrepancies for this report and all subsequent report(s) which may be affected by this correction. Note that Column B should reflect only the Calendar Year-to-Date totals. (52 U.S.C. §30104(b))
2. Your calculations for Line 8 appear to be incorrect. Cash on hand at the close of the current reporting period should always equal the closing calendar year to date cash on hand amount. Please provide the corrected total on the Summary Page. (52 U.S.C. §30104(b))
3. On Schedule A supporting Lines 11a(i) and 11(c), your committee disclosed contributions from "Bleiberg, Paul Mr.," "Balmer, Tom M.," "Bryant, Jay," "Castaneda, Jaime," "Detlefsen, Clay," "Galen, Christopher W.," "Jonker, Jamie S.," "Meshke, Sheryl," "Morris, Shawna D.," "Mulhern, Jim," "Nobis, Kenneth," "Vitaliano, Peter," "Wright, Joseph," and "Dairy Farmers Of America Inc Depac" with an aggregate year-to-date total(s) which is greater than the total receipts disclosed from the individuals and committee. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
