Letter 3: Clarification of Candidate Loan Reporting

Subject: Clarification of Candidate Loan Reporting

To Whom It May Concern:

This Form 99 is submitted to clarify two candidate loan transactions previously reported by the Committee during the reporting period ending December 31, 2024.

During the Committee's post-election reconciliation and review of records in preparation for the Committee's termination, it was determined that two candidate loan entries, each in the amount of \$5,000, were incorrectly reported as loans derived from funds the candidate borrowed.

Upon review of the underlying financial records, the Committee confirmed that the candidate did not obtain these funds through loans from any financial institution or third party. Rather, both \$5,000 advances were made directly from the candidate's personal funds and should have been reported as candidate loans originating from personal funds.

The Committee attempted to amend the underlying Schedule C entries through FECFile. However, because the transactions were originally reported and accepted as candidate loans derived from borrowed funds, the software does not permit modification of the original source designation associated with those entries. After consultation with the Committee's assigned Reports Analyst, the Committee was advised to submit this Form 99 explanation to clarify the public record.

This reporting issue affects only the two \$5,000 loan transactions identified above. The Committee reviewed all candidate loan transactions reported during the current election cycle and confirmed that no other candidate loan entries are affected by this issue.

This clarification does not affect the amount of funds received by the Committee, the Committee's cash-on-hand balance, the outstanding loan balance owed to the candidate, or any contribution, receipt, disbursement, or debt totals previously reported. The sole purpose of this filing is to correct the description of the source of the candidate loan funds and to ensure the public record accurately reflects that the funds originated from the candidate's personal funds rather than from funds borrowed by the candidate.
