This letter is in response to your request for additional information regarding the above-mentioned report. An itemization of the questions raised follows:

On October 2, 2000 we transferred in \$162,159.29 from our non-federal account for joint activity that occurred during previous 60 days. The \$46,648.54 in non-federal joint activity disclosed during the same reporting period is not related to the transfer made on October 2, 2000. No impermissible transfers were made, no further disclosure is needed.

At your request, we have revised some of the descriptions used on Schedule H4. None of the expenditures were made on behalf of federal candidates so further disclosure is not needed. Please find the enclosed amended Schedule H4.

Schedule B line 23 has been amended so that the election designation is clear.
