Consistent with the stipulated judgment in Carey v. In compliance with the Act, all funds previously contributed to the Committee have been deposited into the Committees non-candidate contribution account and will remain non-candidate contribution funds. Effective as of the date of this Amended Form 1, the PAC shall deposit those permissible contributions received into the Committees newly established candidate contribution account.
