I am writing in response to your letter dated November 19, 2003, (copy attached) where you raised issues regarding the AVMAPAC mid-year report (1/1/03 - 6/30/03). For your information, this letter and the amended report are being filed electronically. The attachments will be mailed via certified mail. First, with respect to the \$6,000 disbursement on schedule B for "transfer of refunded contributions that cleared in 11/2002", please note that AVMA did not advance any corporate funds to the PAC. Instead, as explained in detail below, the transfer of the refunded PAC contributions was undertaken in an abundance of caution. In November, 2002, an inadvertent transfer of corporate funds in the amount of \$20,000 was made to AVMAPAC to cover overdrafts. The advance was re-paid by the PAC within approximately two weeks of the transfer. During the time in question, eight checks were drawn on funds including the corporate advance. As we explained to Mr. Nicholas Ebinger of the Commission in a letter dated January 28, 2003 (copy attached), refunds of these checks were requested. The 6,000 transfer to AVMA was for 6 of the 8 checks drawn on the account last November. Although the refunded checks could have been re-deposited in the AVMAPAC account, in an abundance of caution, we elected to keep the funds entirely separate from the PAC account. However, the funds were not originally drawn from a corporate account, because the account was fully repaid by the AVMAPAC on November 25, 2002. To help clarify the situation, we have amended the mid-year report to include a more accurate description of the activity. The amended report is attached. With respect to the failure on the part of AVMAPAC to include occupation information for all receipts over \$200, the omission was due to confusion on the part of AVMAPAC officials on how to categorize certain contributors. Many are retired veterinarians and many are self-employed veterinarians. Based on our discussions, we have included occupation descriptions in the attached amended report.
