Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the Statement of Organization referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received by the response date noted above.** Additional information is needed for the following 1 item(s):

- On your Statement of Organization (FEC Form 1), you have selected a committee type that appears to be incorrect. You indicated the committee is "an authorized committee, and not a principal campaign committee." However, the candidate has not designated a principal campaign committee. Within 15 days after an individual becomes a candidate, he or she must designate a principal campaign committee. This designation is made by filing a Statement of Candidacy (FEC Form 2) (11 CFR § 101.1(a)). Within 10 days after being designated by the candidate, the principal campaign committee must register by filing a Statement of Organization (FEC Form 1) (11 CFR § 102.1(a)). The Form 1 must provide the name, address and type of committee. (11 CFR § 102.2(a)(1)(i))

Please clarify your committee type by amending your Statement of Organization to disclose the correct committee type. If you would like to designate this committee as your principal campaign committee, please check the box 5(a) for "Type of Committee" on Page 2 of the FEC Form 1 and provide any additional information requested for the selected committee type.

Please note you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply

with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
