The Mason Tenders District Council of Greater New York and Long Island (aka MTDCGNYLI; the Mason Tenders District Council of Greater New York; & the Mason Tenders District Council); the Mason Tenders District Council Trust Funds; the Mason Tenders Trust Funds; the Mason Tenders D.C. Trust Funds; & the Mason Tenders Welfare Fund are not non-federal accounts of our committee. MTDCGNYLI is an umbrella organization representing locals of the Laborers' International Union of North America in the NY metropolitan area. The Mason Tenders District Council Trust Funds; the Mason Tenders Trust Funds; the Mason Tenders D.C. Trust Funds; & the Mason Tenders Welfare Fund are ERISA trust funds handling MTDCPAC employee's health & pension benefits. These trust funds also act as our collecting agent. Further, the MTDCPAC leases office space from the trust funds. Disclosed payments include rent & ancillary services such as trash pick-up, utilities, etc. Contributions received are \$.20 per hour contributions from individual union members. Any contributors who reach the aggregate \$200 reporting limit are itemized and reported to the FEC. In addition, contributions received are payroll deductions of \$.20 per hour for each hour worked. Weekly deductions will vary in amount based on the flexible nature and duties of work in the construction industry.
