This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your committee cannot terminate its reporting requirements as you have a loan(s) and or debt(s) owed to the candidate. The loan(s) and or debt(s) must be repaid or, if from "personal funds", the entire amount of the loan(s) and or debt(s) may be forgiven by the candidate. It is important to note that "personal funds" is strictly defined by Commission Regulations at 11 CFR §110.10. If the loan(s) and or debt(s) has been forgiven by the candidate, the Committee should file a Schedule C showing a \$0 balance and a letter signed by the candidate stating the loan(s) and or debt(s) is forgiven. Your committee must continue to file reports until the entire loan(s) and or debt(s) is repaid or forgiven by the candidate. (11 CFR §§102.3(a) and 104.11(a))

Any amendment or clarification should be filed with the Federal Election Commission. Electronic filers must file amendments (to include statements, designations, and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
